Dedicated Marijuana Account (DMA)

Summary:

Questions and concerns for Maryanne Lindeblad, Health Care Authority Director, from the County Authorities Executive Committee Members during the December 13th, 2018 meeting. Questions were emailed to Maryanne on 1.3.2019.

Concern #1: Network Adequacy:

- Can our Board of Directors obtain the names and locations of the providers in the provider networks for each MCO? They are interested in getting an idea of network adequacy in all parts of the region.
- Does HCA assess whether the MCOs have contracts with Providers who will actually “see” *Medicaid* individuals? This is currently a lack of primary care providers in some areas who are willing to actually take on Medicaid patients.
- If there is a currently a shortage of primary care providers willing to provide medical care for those who are on Medicaid, what steps will HCA take and/or require MCOs to take?
- Will MCOs be held to the same “time” and “distance” standards for behavioral health care as the BHOs? Is it true that for physical health care they only need to be able to provide access to 80% of the Medicaid population within a region?

Concern #2: Level of Care:

- Does HCA assess whether the providers in the MCO provider networks are able to provide the necessary level of service?

Since MCOs are able to take a higher admin rate than BHOs and retain a portion for their profit margin, will HCA assess whether this results in a lower level of care.

- Jill Johnson, Island County, said the Conditional Use Permit for the Behavioral Health Facility was received.
- Barbara LaBrash, San Juan County, said they are starting a Drug Court Pilot January 1st. She gave special thanks to Sharon Toquinto for her helpful advice.
- Cammy Hart-Anderson, Snohomish County, had 3 announcements (below):
 - The Carnegie Open House is taking place next week on Thursday from 3-5 p.m.
 - Snohomish County's 10th Homeless Memorial will be held on December 21, with a focus on veterans. Cammy noted the Snohomish County homeless population death rate has increased by 35% during 2018.
 - Snohomish County Council held it's 3rd Annual Legislative Breakfast Forum. Representative Lauren Davis was there and is planning a Stakeholders Meeting in which Cammy was invited. Representative Davis is highly knowledgeable regarding behavioral health issues, especially substance use disorders. Cammy is excited to be part of the conversations that will take place regarding substance use disorders.
- Anne Deacon, Whatcom County said Recovery House is on its way forward with both the provider and the building.
- Ken Dahlstedt, Skagit County:
 - An Opioid Round Table took place last week, that included Federal and state department representatives, providers and others to address and assist the opioid epidemic in rural communities. Help and guidance was sought from those in the field to assist. Pam Rhodes, Pierce County Council Person, is assisting in getting legislative changes. Additional state funding is being sought, as well.
 - The Didgwalic Clinic in March Point is looking to double their capacity. Transportation is their one of their biggest issues. Additional funding is being sought after to assist with the needs.
